**Hunterdon Land Trust (HLT)** is an accredited land trust that was founded in 1996 by a group of forward-thinking volunteers who were concerned about protecting the natural characteristics of Hunterdon County as it grew from a rural community to one increasingly threatened by unplanned development. The HLT mission is to foster healthy ecosystems and communities in the Hunterdon County region through permanent preservation of open space and farmland, stewardship of natural resources, and cultivation of the Dvoor Farm as a center for inspiration, education, and connection.

***Wine and Art at the Farm*** is an important fundraiser in support of the HLT mission. This 3<sup>rd</sup> annual event will be held in our restored Wagon House and rehabilitated Bank Barn on the preserved natural spaces at our headquarters Dvoor Farm property in Flemington, NJ.

**Artist Registration Deadline: Sunday, April 12, 2026.** Registration is free.

**Reception: Saturday, May 16, 2026 (5:00 PM to 8:00 PM)** Art will be on display and available for purchase during a ticketed reception with wine and beer, elegantly catered hors d'oeuvres, and live music. Artists are encouraged to attend the reception and will be offered the opportunity to purchase one (1) general admission ticket at a discounted artist rate of \$40. Additional guest tickets can be purchased at full price with options starting at \$125, subject to availability.

**Exhibition: Sunday, May 17, 2026 (9:00 AM to 1:00 PM)** An open-to-the-public art show and sale will be held during the weekly farmers' market.

**Artwork:** Artists may submit one piece of installation-ready wall artwork and up to three pieces of matted unframed artwork wrapped in protective clear covering. Wall artwork must not be larger than 30" on any dimension or weigh more than 30 pounds. Alternatively, up to four pieces of free standing / table artwork may be submitted. Suitable mediums include painting, drawing, photography, sculpture, mixed media, textiles, ceramics, woodworking, furniture, glass, and jewelry.

Artwork inspired by our natural surroundings is encouraged. Artists living or working in the Hunterdon County region are preferred. Artwork must be original and preferably completed within the last two years. Acceptance of artwork is at the sole discretion of HLT.

All artwork shall be made available for sale at a price set by the artist. If sold, 50% of the price of the work will be retained as a donation to HLT in support of its mission and 50% will be paid to the artist as soon as administratively possible. Unsold work must be retrieved by the artist. See drop-off and pick-up dates below.

HLT Staff and Volunteers will handle artwork with proper care; however, artwork will not be insured by HLT.

**Promotion:** *Wine and Art at the Farm* will be promoted on the HLT website, digitally to the HLT mailing list, and throughout the region using social media, event calendars, flyers, and press releases. Artists are encouraged to share the event details through their own networks.

**Registration:** Artists must provide the following items via email to [info@hunterdonlandtrust.org](mailto:info@hunterdonlandtrust.org) by the **registration deadline of Sunday, April 12, 2026:**

- Completed Artist Registration and Waiver
- Electronic professional quality images of registered pieces. Images (JPEG or JPG) should be under 5 MB with a minimum of 1200 pixels on the longest side. HLT may use the images for promotion of the event.

**Artwork Drop-Off:** at Hunterdon Land Trust Headquarters  
Dvoor Farm 111 Mine Street, Flemington, New Jersey (on the Route 12 circle)  
Artwork must be received in a timely manner to accommodate the installation schedule.

**Artwork Pick-Up:** at Hunterdon Land Trust Headquarters:

Unsold artwork not retrieved in a timely manner shall become property of Hunterdon Land Trust.  
The artist must provide advanced notice to HLT if artwork will be picked up by an agent of the artist.
